Latvian Championship in alpine technique

"REMOSS KAUSS 2025" REGULATIONS

1. PURPOSE AND TASKS

- 1.1. To popularize and promote alpine technique competition in Latvia;
- 1.2. To clarify best teams in alpine technique competition;
- 1.3. To develop an international experience exchange between different member state participants.

2. PLACE AND TIME

2.1. Competition is placed on Jelgava Sport Hall (Mātera Street 44A, Jelgava, Latvia) on March 1., 2025.

3. ORGANIZERS

- 3.1. The main organizers are NGO "REMOSS", reg.Nr 40008033762, in cooperation with Latvian Alpine association (LAS), Jelgava state city municipal authority "Sporta servisa centrs", SIA "REMOSS-S" and competition supporters. Competition referees are from REMOSS.

- 3.4. Competition main organizer: Kristīne Hofmane, tel. + 371 28366305 (LV, ENG)

4. PARTICIPANTS

- 4.1. In competition participate teams with 4 members, of which at least one lady.
- 4.2. In competition can participate competitors older than birth year 2010. Restriction teams can have up to 2 members younger than 2008 (Youths).
- 4.3. If the participant is younger than 18 years, participation in competition is allowed only with coach or parent permission, which is confirmed by signatures on the application given at the reception on the morning of the competition.
- 4.4. In competition there are two groups: sportsmen and amateurs. In a case of a small number of teams, organizers have rights to make one group.
- 4.5. Each team is responsible for its own team and individual equipment. Referees before the team start on route check if equipment complies with rules. If not, for security reasons, it will be forbidden to participate in the route.

5. APPLICATIONS

- 5.1. Registration is active <u>till February 26, 2025</u>, filling application form in electronically here: <u>https://forms.gle/kRDHc3hmtQkKe4NC9</u>
- 5.2. Registration can be closed faster, if the number of teams reach 25.
- 5.3. After successful registration the team will receive a confirmation on their email address.
- 5.4. Till February 27, on team email address will be sent route descriptions and schemes, as well as recommended equipment list.
- 5.5.If there are more questions, the team can contact organizers on mail <u>remoss.latvia@gmail.com</u> or by the phone numbers above.

6. COMPETITION PROGRAM

- 6.1. Registration from 8.30 till 9.00.
- 6.2. Competition open ceremony at 9.00
- 6.3. Explanation of routes at 9.15
- 6.4. Qualification route time from 10.00 till 19:00
- 6.5. Awarding ceremony: half an hour after the results are notified
- 6.6. The competition will take place in 1 round for both groups (sportsmen and amateur): festival principle.
- 6.7.Competition program can be changed according to the number of teams. Organizers have rights to change program as required, informing all teams timely.

7. ROUTES

- 7.1. Competition can contain following alpine technique elements: horizontal, vertical movement on ropes, rescue, dry tooling, speleo, descending, pendulum, installation of safety points, rope elements, ect.
- 7.2. Team participates using certified equipment according to regulations. Organizers provide safe equipment for route installation. In separate routes organizers provide special equipment.

8. RATING

- 8.1. Competition is rated according to 06.07.2021 Latvian alpine association rules of alpine climbing competitions (link: <u>https://ej.uz/86w5</u>) considering adjustments on route descriptions specified by the organizers.
- 8.2. In routes the team score is determined by summing up the points gained in the routes and subtracting the penalty points. The team with the highest score ranks higher. In case of equal result, higher place will get a team that spends less time on all routes.
- 8.3. In the case of claims, the team can submit a complaint, by making a security deposit Eur 20.00. A complaint needs to be written, signed by the team captain and submitted no later than half an hour after announcement of the results. If a complaint is justified, security deposit will be returned. If a complaint is not justified, the security deposit will not be refunded.

9. AWARDING

- 9.1. The first three places in each group are awarded with medals and awards.
- 9.2. The winning team of the sportsmen group is awarded also with a traveling cup.
- 9.3. Organizers have the right to give special prizes to the most attractive teams according to their own opinion.

10. COMPETITION ENTRY FEE

- 10.1. The organizational costs of competition are paid by organizers and supporters.
- 10.2. The competition entry fee for the team is Eur 80.00. The team can pay the entry fee at registration in cash or with transfer, timely informing organizers.
- 10.3. If a team does not arrive to competition, cannot participate according to technical unpreparedness or health problems, as well as the team has been disqualified, the entry fee will not be refunded.

11. OTHER RULES

11.1. By registering (filling the application form on the competition day), the participant confirms with a signature that he / she has read and agrees with and will follow competition rules. As well as take full responsibility for their health and technical preparedness. About minors a coach or parent sign and takes responsibility.

- 11.2. Organizers may not allow the team to participate in route if there are reasonable grounds to suspect that team members are under the influence of alcohol, narcotics or psychotropic substances.
- 11.3. Participants, coaches and supporters must follow the safety rules. Helmets near the routes are mandatory!
- 11.4. Teams are responsible for their personal belongings and equipment. The organizers are not responsible for the belongings left at the competition place.
- 11.5. Organizers have rights to use the photo and video taken during the competition for marketing and advertising purposes without the agreement of people who appear there.

12. PROCESSING OF PERSONAL DATA

- 12.1. Controller of personal data processing in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (April 27, 2016) on the protection of natural persons with regard to the processing of personal data and the free movement of such data and which repeals Directive 95/46/EC (General Data Protection Regulation) is the NGO "Remoss", registration number: 40008033762, e-mail: normunds.remoss@inbox.lv.
- 12.2. Personal data of the participants name, surname, birth data, photos and videos taken during the competition are processed for the purpose of organizing the competition, publishing the results of the competition, and informing the public about the progress of the competition. Competition photos, video materials can be used for the creation of publicity materials, as well as for archive accumulation, documentation and preservation purposes.
- 12.3. The responsible person of the team/club, when submitting an application and registering participants for the competition, confirms that the participant is familiar with the regulations of the competition, including the rules for processing personal data, and gives consent to the processing of the participant's personal data.
- 12.4. The person has the right to contact the Controller to withdraw the given consent, correct or delete the data, or limit the processing or object to the data processing if illegal data processing is detected; to obtain information collected about him for the personal data processing purposes indicated above; to obtain information about those natural and legal persons to whom information about this data subject has been issued.
- 12.5. No automated decision-making is carried out regarding the processing of personal data.
- 12.6. Personal data is not intended to be sent to a third country that is not a member state of the EU or EEA or an international organization.
- 12.7. If a person detects a violation of personal data processing, he has the right to submit a claim to the implementer of the purpose of data processing, the Controller or the Data State Inspectorate.

The regulations are also an invitation to the competition.
